Sat 9th Oct was a WA25m & WA18m open tournament, and we had a large number of archers from across the SCAS Region including Essex and Cambridge, to name just a few and amongst them was Matt who we haven't seen for years. It was just nice to catch up, have a laugh, and shoot together. HAA pda's were one of the main topics v Essex's Danage timing system. Holiday pending in Essex....

After a conversation with Charlotte Hicks re a spelling error on the target list and chatting about how much admin work the event takes of my time and others behind the scenes, we joked about the submitting of claims to AGB. So, Charlotte very sheepishly, came up to me, after the WA25m to say that her son, "Oliver" had broken the European & World Cadet & Junior records. 22.07.11 Judges' Liaison Officer:

Happy New Year to you all!

There have been a few changes to the Judges List since the last meeting. Firstly many congratulations to Alex Purser from Essex who passed his National Assessment, to David Strong from Hampshire who passed his Regional Assessment and Graham Pink from Oxfordshire who passed his County Assessment. Congratulations to them all. We have also have a new Candidate, Meera Shah from Middlesex has joined the team.

Unfortunately we have also had some retirements. Gary Bellamy from Hertfordshire had been a Judge for 6 years and was a Regional Judge. Netta Bridle from Middlesex had been a Judge for 18 years was also a Regional Judge. They will be greatly missed by their fellow Judges and the archers and I thank them both for all their hard work over the years

Sadly David Wallace passed away on 8th September. He retired as a Judge in 2015 after over 20 years in the role, he was particularly well known for his extensive knowledge of Field archery in which he was a National Judge. On his retirement he was awarded the title of SCAS Judge Emeritus in recognition of all his hard work over the years.

Last weekend we had the SCAS Judge Conference. Due to the current situation we decided to hold it on-line again. It was well attended and as well as the normal AGM business we held training on the up coming World Archery Rule changes. The Annual Returns for Judges have been collated and are still reduced in 2021 with XXX days were done by the XX Judges who sent in their Returns out of 53 Judges. The Judge Committee have recently purchased a 60lb weight to enable our Judge's scales to be calibrated more easily.

The list of Appointments for National Tournaments has been published, with SCAS Judges, once again, being well represented, quite often as Chair of Judges or as Director of Shooting. SCAS Judges are also well represented at World Archery and World Archery Europe events, including being Chair of Judges at the World Para Championships and being Event Director at the World Games in America. Our two Continental Judges, Lee Miller and Gareth Beeby are also hoping to attend the World Archery Judge Upgrade Seminar in Colombia in April.

World Archery are introducing some changes to their Rule Books which come into effect on 15th January. Quite a lot of the changes, such as the changes in timings, do not apply in the UK. The main ones which will affect archers here are

- Equipment Failures will no longer be allowed at World Archery events, this only applies to Target events. So if your equipment breaks you do not get to make up any arrows you have not been able to shoot.
- There have been some name changes. Cadets will be known as U18, Juniors will be known as U21 and Masters will be known as 50+
- Vibration dampeners will be allowed on Barebows. However everything must still pass through a 12.2cm ring without being flexed. Angular brackets and connectors will not be allowed. As Archery GB has the same equipment rules as World Archery this change will apply to all AGB events as well.
- In Field and 3D the Instinctive Bow is being replaced by the Traditional Bow. As Archery GB has the same equipment rules as World Archery this change will apply to all AGB events as well.

As it is January I'm afraid it is time to look at our budget for the coming year.
