- 2020 happened (there is not much else you can say!)
- Of the 50 Annual Returns (out of 57) there was a total of 211 days Judging
- There are currently 56 Judges in SCAS (at 01/01/2021).
- This is made up of 20 Nationals (including International and Continental grades), 12 Regionals, 15 Countys and 9 Candidates
- Average of 4.22 days of Judging in 2020 (in 2019 it was 17.54 days)

- Bill Kinsella Bill has been a Judge since 2011 and was a firm fixture at many tournaments, particularly those in Bedfordshire. His dedication and good spirits are greatly missed.
- Maggie Woolf Maggie has been a Judge for a great many years and is well known in Middlesex and all around SCAS. She did particular work with juniors and the disabled.
- Neil Dimmock Neil has been a Judge for 46 years raising through the ranks until he became an International Judge in 1993, a position he held until the age limit made him retire as an International Judge in 2008 and he was awarded the title of WA Judge Emeritus, he continued as a Continental Judge till 2011. Neil has made an enormous contribution to archery and to judging during his long and distinguished career. There are too many things to mention them all but some highlights are being Chairman of the SCAS Judges Committee, DOS at the Paralympics in Beijing, working closely to progress para-archery and training judges in the UK and all round the world.

Online J07

Archery GB have launched the online J07 for Annual Returns. Some issues with people accessing it, but hopefully these will soon be resolved. Thank you to all of you who have used it, it will help AGB better understand the types and number of shoots we do.

Learning Curve

- The Working Group have launched some on-line training on Learning Curve and plan to add more in the future.
 This is aimed to help new Judges and also act as a refresher for all.

New Shirts

The roll out of the new shirts has been extended, you can continue to wear the old shirts until April 2022. However the new shirts must be worn at National Tournaments.
 Don't forget that you can claim one free shirt from AGB and the cost of a shirt from SCAS.

J Armband

 The Judges Working Group has decided to stop issuing the J Armband for Candidates. If you have one you can continue to wear it, but there is no need to.

- SCAS Judge Training Presentation and Training Resources
 - The SCAS Judge Training Presentation and Training Resources have been updated to reflect the new rule changes in place at the moment and uploaded to the SCAS website. If you spot any mistakes or issues then please let me know. We have also added a new one called "COJ Checklist"
- World Archery Judge Summit
 - World Archery ran a summer summit for Judges featuring a number of videos and articles which you may find interesting, in particular the one on "What makes a good Judge". You can also spot several familiar faces

- Archery GB Rule Changes
 - In April there were some minor amendments due to coronavirus
 - 301 (b) (i) Outdoor range layout minimum spacing of target boss centres for archer shooting in pairs or singly is now 3.66m (12 foot)
 - 301 (b) (iii) the ability of archers to shoot in threes has been removed
 - 402 (c) Indoor range layout bosses should be placed a minimum of 2m apart.
 - These changes are temporary but likely will be enforced throughout 2021.
 - 302 (d) (iv) The whole safety area must be visible. Additional lighting such as flood lighting can be used to achieve this

- Archery GB Rule Clarifications
 - Arrows which are painted do not have to follow the same rules as arrow wraps (22cm long etc). However the paint cannot be used as an aiming point or draw check indicator.
 - KG Phantom bow this bow incorporates lead weights and silicone shock absorbers. It cannot be used as a Barebow as is as the shock absorbers are not built in, however if these are removed and the weights are fixed directly to the bow then it is okay.

- World Archery Rule Changes
 - Rule changes in Target
 - Introduction of Barebow to Target
 - Minimum space per archer outdoor is now 90cm
 - Clarification that compounds can have a lip and nose mark, but W1 can only have one
 - Clarification on shoot off procedures for W1 archers
 - Clarification that in Target the serving on Barebow strings cannot end in the line of sight (as with Recurves)
 - Rule changes in Field/3D
 - Introduction of Mixed Team in Field and 3D
 - Rule changes in Run Archery
 - Rules on Run Archery expanded

What's coming up in 2021 - Rules

- Archery GB Rule Changes in immediate effect
 - Appendix B which deals with Judging has been updated
 - Clarification on the number of Judges required at events and that this should be discussed with the Judge in Charge.
 - Candidate Judges are considered as part of the team and should receive the same benefits e.g. expenses and catering. A maximum number of candidates is also quoted
 - If a Judge of any level requests to attend a shoot for experience etc then they should not expect expenses or catering unless offered by the TO
 - Details about expenses and catering should be made clear before the Judge agrees to attend a shoot.

What's coming up in 2021 - Rules

- World Archery Rule Changes
 - Changes to the Field and 3D Head to Head procedures, in particular relating to shoot offs for tie and Mixed Team
 - Change in the shoot off procedure for Target.
 Previously if recurves/barebows scored a 10 or compounds shoot an X there would be another arrow shot. It has now changed back to the previous rule the highest scoring arrow wins, if this is the same then the arrow nearest the middle wins. If the distance is the same then another arrow is shot

What's coming up in 2021

- County Re-accreditation
 - We are now in the midst of the County Re-accreditation. The reaccreditation periods for the other grades are
 - Oct 2016 Jan 2021 County
 - Jan 2019 Jan 2023 Nationals
 - Jan 2020 Jan 2024 Regionals
- National Judge Seminar
 - The National Judge Seminar is being held online this year, the date is still to be decided.
- Changes to the Working Group
 - An additional Group for Judge Training and Development is being introduced. All Judges of National level or higher can apply
 - Nominations are also being taken for the Judges Working Group. All Judges of County level or higher can apply
