Guide to moving through the Grades

This Guide has been created to try and give you some more information on moving through the grades of Judging. In particular information on what to expect at your assessment. The SCAS Judges Committee understand that the thought of assessments and exams can be nerve wrecking (let's face it, we all hoped that we had finished with tests when we left school!), so we try to do everything we can to make the process as transparent and as stress-less as we can. Hopefully this document will help with this, although please bear in mind that things might change slightly depending on the tournament, weather, timings and any other personal circumstances.

All SCAS Assessments are done at Outdoor Tournaments only. We aim that the assessments are done at Record Status Tournaments; for Regional assessments it will always be at a Record Status or World Record Status Tournament. We also try to arrange assessments for a venue where you have not judged before – this tries to make sure that all assessments are done on a 'level playing field'.

All assessments consist of a written exam and on the Field assessment. The written part will happen at a Seminar or following a series of webinars and the on the Field assessment will take part at a tournament.

You can choose whether you would like your practical assessment to be done at a Target or Field event, I would suggest you choose the discipline that you feel most comfortable with.

We try to make sure that the questions are clear and none are written to trick you. Whilst there are no specific example papers the previous National, Regional and County re-accreditation are available.

The On the Field Assessment is your chance to show that you know how to put the rules into practice. You will be in charge of checking the field to make sure it is all correct, and you will need to organise the equipment inspection. You will also need to prepare an opening address to show to the assessor and Chair of Judges. You will probably be asked to deliver the opening address you have prepared and also make other announcements during the day. You will also probably be asked to control the timing and whistles for at least part of the day.

You can do the two parts in any order, but you need to pass both parts to qualify, and if you are successful then your new grade takes affect straight away.

Candidate to County

Are you ready to put in for assessment?

- The written part of the exam can happen either at the end of the Candidate Seminar weekend. These Seminars will tend to happen at Archery GB headquarters at Lilleshall at the end of October. All Candidates who have not yet attended a Seminar will be contacted when the details of the next Seminar are available.
 - Or you can complete the e-learning (when available) and attend a webinar online. After this you can request to do the written paper when you are ready. The paper will be timed. Details of the webinars are on Sport:80 and in the SCAS Judge Communication.
- You can attend the Seminar or do the e-learning/webinars at any point during your time as a Candidate, although it might be better to attend it soon after becoming a Candidate so you can put what you learn at the Seminar into practice on the Field and become confident in it before you do your practical assessment.
- Before you apply for your practical assessment you should have met the other criteria as laid out in the J10 (please check the current version). Currently they include
 - Have had experience in assisting higher qualified Judges for a minimum of 12 Judging days at tournaments.
 - A tournament can consist of more than one day. If the 2nd or any subsequent days do not require a full field re-check and a full archer's equipment recheck then it is classed as one tournament. For example a 1440 on day 1 and a 720 and H2H on day 2 would count as 1 tournament. A York Hereford followed by a 1440 would count as 1 tournament. But a Double National on day 1 and a Clout on day 2 would count as 2 tournaments. If you are unsure then please ask your JLO or the Judges Working Group for information on a specific event. For Field Events where a field check is performed on a the day before the competition this would count as 1 tournament and the actual tournament would count as another competition
 - There should be a minimum of one day at each discipline Target and Indoor and one of either Field, Clout, 3D, Run or Flight.
- Whilst you do not have to have attended the Candidate Seminar/webinar and done the written test before your practical assessment it is probably useful.
- Most importantly before applying for your practical assessment make sure that you are happy within yourself and feel you are ready to become a County Judge. Also, discuss it with your mentor. Your mentor should be able to advise if there is any area they think you need to concentrate on or if they also agree you are ready. Remember when you pass you must be prepared to be Judge in Charge at Non Record Status Tournaments.

- As it can take a while to arrange an assessment you can apply in advance of meeting all the requirements. For example if your 12 events will be complete on 1st May, you can apply early so the assessment can be arranged to take place after the 1st May. However it is always best to discuss it with the JLO before completing your application.
- Once you have passed your practical and written paper and completed the other criteria as laid out in the J10 you will be a County Judge and your new grade will take effect straight away.

How to apply for assessment and how they are arranged

- To apply for practical assessment you need to complete the J01 send it to the JLO.
- When you send in your application please also include a list of weekends when you are available for assessment (or weekends when you are not available, whichever is easiest).
 With the increase in two day tournaments, please make sure you include Saturdays as well as Sundays.
- The JLO will then use these dates to try and find a suitable tournament for your assessment. Please bear in mind that suitable tournaments are often hard to find as they have to be Record Status, of a suitable size, be on a day when you and an assessor are available, not be too far away from you and have an Organiser that is willing for us to do the assessment. So it might take some time to find somewhere, so the more available dates you can give the easier it is. Generally County Assessments are done at Record Status Archery GB Rounds.
- Once the JLO has found a suitable tournament they will contact you to double check that the
 date and location is okay for you. Then they will arrange everything with the Chair of Judges
 and Tournament Organiser and confirm back to you when everything is in place.
- As the tournament will be being used for your assessment there is no requirement for the
 Organiser to offer you travelling expenses, or to give you a gift at the end of the tournament.
 The JLO will ask the Organiser if they are willing to cater for you, if they are not the JLO will
 let you know (most Organisers are very helpful and will cater for people being assessed).
- You can claim travel expenses from SCAS at the current Archery GB rates for your first practical assessment at each level. The JLO will provide you with a claim form following your practical assessment.

How to prepare for the assessment day

- Obviously make sure you read the Archery GB and World Archery Rule Books, also make sure you read the WA Judge's Handbook and don't forget the SAPs from Archery GB.
- Make sure that you know where the tournament is and how long it will take to get there.

- Make sure you have your previous J05s ready to give to the assessor on the day
- Make sure you have the correct official Judges uniform to wear on the day (or be able to provide proof that you have ordered the uniform before the assessment)
- o Prepare an opening address for the tournament
- Talk to your mentor to see if they have any advice or guidance
- o If you have any questions, then ask the assessor or the JLO

On the day

- As normal make sure you arrive at least 1 hour before, and when you arrive introduce yourself to the Organiser, Chair of Judges, Assessor and any other Judges. Have your J05s ready to hand over to the assessor. Remember that today is your opportunity to show the assessor what you can do.
- You will be in charge of checking the venue, safety distances, targets, faces etc, so you will
 need to ask the other Judges for assistance and explain to them what you would like them to
 do.
- You will also be involved in checking archer's equipment so you will need to demonstrate you can do this for all bow styles.
- Once the field has been checked show your prepared opening address to the assessor and Chair of Judges and go through it with them, also discuss with them where they would like you to be on the field and what they want you to do.
- For the rest of the day you will be working as a normal Judge, you will probably have to do some announcements and control the timing / whistles for part of the day. During this time the assessor or other Judges might ask you various questions to assess your knowledge.
- Once all this has been completed you will then be told whether you have passed or failed the practical assessment.
 - If you have failed then the assessor will explain to you where the issues are and information on what you can do to improve. If you need any more information or any help to fill in the gaps don't hesitate to contact the JLO or your mentor and ask for their help. There is a waiting period of 6 months before you can apply for reassessment.
- As normal you are expected to stay until the end of the tournament and attend the prize giving (unless personal circumstances mean you can't, in which case let the assessor and Chair of Judges know when you arrive). Please also make sure you thank the Organiser for allowing you to attend.

What next?

- Once you have passed your County Assessment the choice is yours on whether you start
 working on becoming a Regional Judge straight away, take some time as a County Judge
 before thinking about becoming a Regional Judge or decide that you do not want to progress
 any further. Whatever you want to do is fine, but it is recommended that you keep getting
 J05s as these will help you develop.
- o If you do decide you would like to progress to Regional Judge then it is advisable to do a wider range of shoots as possible, and to work with as many different Judges as possible so you can learn from them all. You may also want to look at doing some larger shoots and try to do more World Archery tournaments (such as 1440s) for experience. It is also a good idea to do some smaller Non Record Status shoots where you are Judge in Charge. There is no reason why a County Judge should not be in charge of a tournament which is Non Record Status, even when there are higher graded Judges there, so talk to your fellow Judges and ask if you can be in charge at a future tournament for experience. Also make sure you volunteer for SCAS tournaments.

County to Regional

A lot of things are exactly the same as when moving from Candidate to County, it is really just the level of knowledge needed that differs.

Are you ready to put in for assessment?

- o The written exam can only be taken a minimum of 2 years are qualifying as a County Judge
 - The written part of the exam can happen either at the end of the County Seminar weekend. These Seminars will tend to happen at Archery GB headquarters at Lilleshall at the end of October. Or you can complete the e-learning (when available) and attend two webinars online. After this you can request to do the written paper when you are ready. The paper will be timed. Details of the webinars are on Sport:80 and in the SCAS Judge Communication.
- Before you apply for your practical assessment you should have met the other criteria as laid out in the J10 (please check the current version). Currently they include
 - Have a minimum of 18 tournaments judged as a County Judge at tournaments.
 - A tournament can consist of more than one day. If the 2nd or any subsequent days do not require a full field re-check and a full archer's equipment recheck then it is classed as one tournament. For example a 1440 on day 1 and a 720 and H2H on day 2 would count as 1 tournament. A York Hereford followed by a 1440 would count as 1 tournament. But a Double National on day 1 and a Clout on day 2 would count as 2 tournaments. If you are unsure then please ask your JLO or the Judges Working Group for information on a specific event. For Field Events where a field check is performed on a the day before the competition this would count as 1 tournament and the actual tournament would count as another competition
 - Three of the days must have been at World Record Status Tournaments, three at other Record Status Tournaments and two Indoor Tournaments
 - ❖ A minimum of 1 event must be at each discipline Target and Indoor and one of either Field, Clout, 3D, Run or Flight.
 - You must have attended at least one Regional Judges Conference or Archery GB Judges Conference in the previous two years
- Whilst you do not have to have attended the Regional Judge Assessment Seminar/done the webinars and done the written test before your practical assessment it is sometimes useful.
- As well making sure that you are happy within yourself and feel you are ready to become a Regional Judge make sure you discuss it with your mentor. Your mentor should be able to advise if there is any area they think you need to concentrate on or if they also agree you are ready. Remember when you pass you must be prepared to be Judge in Charge at Record Status Tournaments or World Record Status Tournaments with a Head to Head, which means you could be in charge of your County Championships.

As it can take a while to arrange an assessment you can apply in advance of meeting all the
requirements. For example if your 18 tournaments will be complete on 1st July, you can
apply early so the assessment can be arranged to take place after the 1st July. However it is
always best to discuss it with the JLO before completing your application and if you one of
the tournaments you have planned does not take place your assessment may be cancelled.

How to apply for assessment and how they are arranged

- To apply for practical assessment you need to complete the J01 and send it to the JLO. As before let the JLO know what dates you are available for assessment
- Once the JLO has found a suitable tournament they will contact you to double check that the
 date and location is okay for you. Then they will arrange everything with the Chair of Judges
 and Tournament Organiser and confirm back to you when everything is in place.
- Regional Assessments will be carried out at either Record Status or World Record Status tournaments.
- As the tournament will be being used for your assessment there is no requirement for the
 Organiser to offer you travelling expenses, or to give you a gift at the end of the tournament.
 The JLO will ask the Organiser if they are willing to cater for you, if they are not the JLO will
 let you know (most Organisers are very helpful and will cater for people being assessed).
- You can claim travel expenses from SCAS at the current Archery GB rates for your first practical assessment at each level. The JLO will provide you with a claim form following your practical assessment.

How to prepare for the assessment day

 Your preparations should be exactly the same as for County assessment (but by then you should have a full Judge Uniform). If you have any questions, then ask the assessor or the JLO

On the day

- The assessment day will be in a very similar format to the County Assessment. This is your chance to show the assessor what you can do and how you apply the rules.
- You will need to demonstrate that you can act as COJ, so you will need to give thought to and create a work rota for the Judges, take control of the venue and equipment check and act as COJ for at least some of the day.

- You will be asked questions during the day which are a bit more in depth than the County practical, but there will still be no complicated 'what if' questions or anything relating to Head to Heads. The questions are a mix of Archery GB and World Archery and there may be questions on Target, Field and Clout rounds.
- o Once all this has been completed you will then be told whether you have passed or failed
 - ❖ If you have failed then the assessor will explain to you where the issues are and information on what you can do to improve. If you need any more information or any help to fill in the gaps don't hesitate to contact the JLO or your mentor and ask for their help. There is a waiting period of 6 months before you can apply for reassessment.
- As normal you are expected to stay until the end of the tournament and attend the prize giving (unless personal circumstances mean you can't, in which case let the assessor and Chair of Judges know when you arrive). Please also make sure you thank the Organiser for allowing you to attend.

What next?

- Once you have passed your Regional Assessment the choice is yours on whether you start
 working on becoming a National Judge straight away, take some time as a Regional Judge
 before thinking about becoming a National Judge or decide that you do not want to progress
 any further. Whatever you want to do is fine, but it is recommended that you keep getting
 J5s as these will help you develop.
- O If you do decide you would like to progress to National Judge then it is advisable to continue to do a wider range of shoots as possible, and to work with as many different Judges as possible so you can learn from them all. Again try to do some larger shoots, for example get experience of Head to Head Rounds. Also try to be in Judge in Charge at some Record Status Rounds and World Record Status Rounds, as before there is no reason why you cannot be in charge and have more senior grades working for you, it is a great way to get experience. Also volunteer for more SCAS and National Tournaments to increase your knowledge and experience.

Regional to National

National assessments are controlled and organised by the Judges Working Group so are done slightly differently

Are you ready to put in for assessment?

- Feel free to discuss your desire to progress with your mentor or the JLO, they will be happy to advise you and help you prepare for the assessment. Remember when you pass you must be prepared to be Judge in Charge at World Record Status Tournaments with Head to Heads, which means you could be in charge of a Head to Head Tournament, for example The Masters at Lilleshall.
- There are also some requirements which have to be met (you start from zero again when you qualify as a Regional Judge; these are detailed in the J10, so please check the current version). Currently they include
 - ❖ You must have judged a minimum of 25 days at tournaments
 - ❖ Ten of the days must have been at World Record Status Tournaments or National Tournaments, of which two will be Head to Heads. Four of the judging days must be as COJ at a UK Record Status event or Judge in Charge at a WRS event without a Head to Head.
 - ❖ A minimum of 1 event from each discipline − Target and Indoor and one of either Field, Clout, 3D, Run or Flight.
 - You must have attended at least one AGB Judges Conference in the two years before you applying

How to apply for assessment and how they are conducted

- To apply for assessment you need to complete the J03 and send it to the JLO. They will then check it and sign; then forward it on to the Judges Working Group.
- All applications must be with the Judges Working Group by the end of September for assessment the following year. You must have completed all the requirements in the J10 before applying.
- The National Assessment is held in two parts
 - On the Field this is done at a World Record Status Outdoor Tournament. Make sure you apply for National Tournaments as normal for the year you want to be assessed in. Details of what will be expected of you will be given to you by the AGB Working Group and your assessor, but it will probably include organising checking

- the field, organising equipment inspection and the Judges work rotation and giving the opening address. You will also probably be asked questions during the day
- ❖ Written Paper and Discussion this is done at Lilleshall, traditionally towards the end of October. At the end of the day you will know the result.
