- New Candidates

 - Guy Perring from Oxfordshire
 - Georgina Cutts from Buckinghamshire
 - Martin Whiting from Hampshire
 - Ted Tricker from Bedfordshire

- Passings
 - Ken Arton, from Buckinghamshire, passed away in March.
 Ken had been involved in Judging since it started, and
 when he retired in he was awarded the title SCAS Judge
 Emeritus. He continued as Bucks President for many years
 - Fionna Stamp, a long standing SCAS Judge Emeritus passed away in the summer
- Retirements
 - Tony Ikel from Essex after 25 years
 - Ted Burnham from Berkshire after 16 years
 - Simon Cooper from Sussex after a year

Other news

- Tori and Richard Mill got married in August
- Peter Turner was awarded the SCAS Gold Plaquette and Silver Plaquette from Archery GB
- Paula Golding (Retired) was awarded the SCAS President's Medal
- Derrick Lovell MBE and Neil Dimmock were both awarded World Archery Europe Diplomas
- Hannah Brown was Technical Delegate at the World Field Championships in Ireland
- Graham Potts was Chair of Judges at the Rio Olympics

Other Changes in 2016

- Archery GB Rule Changes
 - At all Record Status and above tournaments there will be mandatory equipment inspection for all
 - Judge Grades at tournaments. Regional Judges can now be Chair of Judges at World Record Status Tournaments where there is no Head to Head
 - "Other" Metric Rounds can be shot in ends of 3 or 6
 - Rounds shot to Method 2 can now be shot using traffic lights/countdown clocks
 - New 72 arrow single distance, Rounds for Juniors
 - Unmarked Field Rounds will be shot before the Marked Field Rounds
 - Sighters are now allowed before each AGB Round and archers can claim records for any the 2nd or 3rd Round of the day

Other Changes in 2016

- World Archery Rule Changes and Clarifications
 - Rule Change on what to do if there is a difference between paper and electronic scorecards
 - Rule Change with regards to bouncers and pass throughs, if there is physical evidence where the arrow came from then you can give that value rather than the value of the lowest unmarked hole
 - Camouflage on equipment is banned at all World Archery and Continental Organised Tournaments. Reminder – this does not apply to WA Rounds in the UK
 - Target Numbers no longer need to alternate between black on yellow and yellow on black
 - Change to the outer margins on Field Faces
 - Bjorn Faces can no longer be used at WRS or Arrowhead events
 - Release Aids are not to be attached to the string before the arrow in Matchplay
 - Various amendments and clarifications relating to Para and VI Rules
 - Various Clarifications on 3D and Field Archery in particular with barebows

Other Changes in 2016

- Judge Uniform
 - The National Committee extended the trousers in the uniform to include
 - i) Kudos the trousers from the current uniform supplier
 - ii) Henbury Chinos in Stone
 - iii) ProJob Cargo Workwear in Stone
 - iv) Craghoppers KIWI PRO in Stone
 - v) 5.11 TDU TacLite Pants in Stone
 - vi) Regatta Action Trousers in Stone
 - vii) WA or WAE uniform trousers

What's coming up in 2017

- Ground Inspections
 - Starting in April 2017 all Clubs must self-certify that all their venues meet the Rules of Shooting. If they need dispensation then they will need to apply to Archery GB who arrange for their venue to be inspected by a trained Inspector. This is no longer the responsibility of the Judges
 - However at ALL Tournaments you MUST still check that the Field of Play meets the Rules of Shooting, this includes the overshoot behind the targets and the Safety area to the side of the targets.
- J Forms
 - The National Committee are working on revamping all of the J Forms including the J10.
- Regional Preparation Seminar
 - The first Regional Preparation Seminar is to be held at Lilleshall on 4th March, part of the day will be the Regional written paper, in the same way that the Candidate Seminar includes the County written paper.
